COMMISSIONS

Once the 1p test has been done on the card machine it will show up as an active account on our CRM system.

- Once the account is classified as active you will then receive your commission payment.
- If the invoice is approved before 4pm you will receive your payment/s same day.
- Please do not send in photos of the receipt this is not needed.

Earn **£200** commission when selling terminals at their associated monthly rental charge.

(Additional **£10** commission for every **£1** of additional terminal rental up to a maximum of **£32**).

ADDITIONAL BONUS COMMISSION

- All calculated on a per terminal basis.**
- All 'Simple Rate Packages' include Premium Faster Processing as standard.**
- All contract duration will be 18 months as standard.**
- Should you need anything outside the above please talk to your manager, deviation from the pricing guidelines published will result in a £25 deduction in commission per terminal.
- Telesales appointed sales commission is reduced by 20% per terminal, there is no change to ALP bandings or thresholds.





AGENT LOYALTY PROGRAM (ALP)

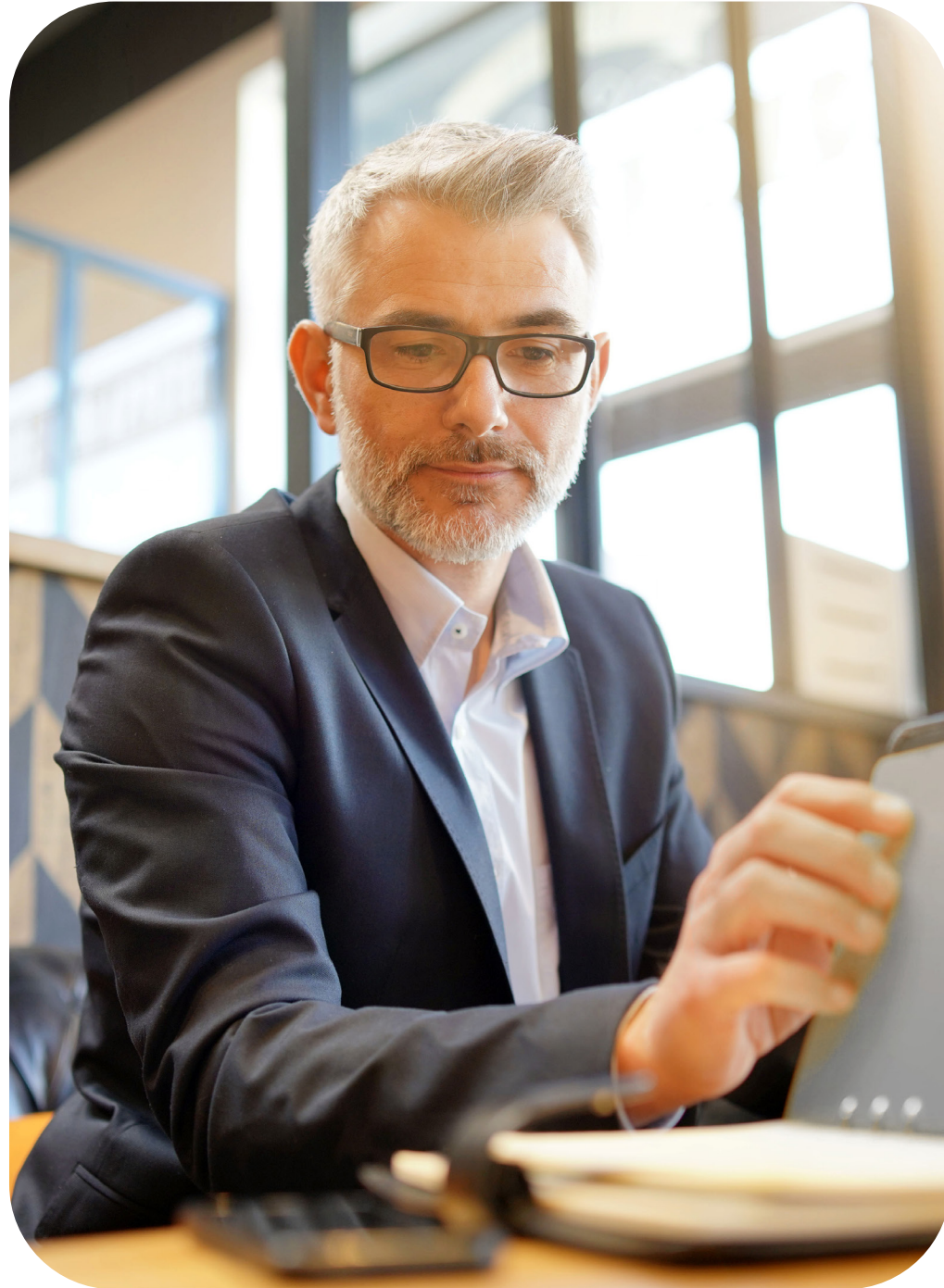
UTP appreciates the work that is put in by the Agents and Affiliates working with us and would like to reward their loyalty accordingly. Below is a table that offers percentage share when certain thresholds are achieved. As with all our plans this is based wholly on live sales.

Once the stated thresholds have been achieved MSC is paid on all active accounts within your portfolio.

Payment is one month in arrears. So, 10 terminals in February will generate a payment (at the latest) last working day of March.

Number of points per month	Bonus payable per month
5 Terminals	10% of MSC income
10 Terminals	17.5% of MSC income
15 Terminals	25% of MSC income
20 Terminals	35% of MSC income





RENEWALS

When an account has one month remaining, an agent or affiliate is permitted to resign the account on the same terms as an 18-month agreement. If an account has not been resigned and enters a rolling stage, UTP Group reserves the right to resign the account.

For any changes in the terms of this agreement, authorisation would be required by your respective manager.

VIRTUAL TERMINAL

Virtual Terminal (VT) pricing

All transactions via virtual terminal will be Card Not Present (CNP) which means that you cannot use it to do a face-to-face transactions.

Please see Credit and Debit Card price list for prices above in rates section:

- No monthly charge (other than the standard £20 MMSC applicable to a merchant account);
 - Authorisation charge of 3p per transaction
 - Joining fee can be from £25 up to £150

COMMISSION: Self-generated leads on VT's are paid at £50 per VT.

***VT and ECOM applications require full merchant agreements to be filled in.**





CASH ADVANCE

Loans over £20000 will be looked at on a case-by-case basis.

Clients must have been transacting with UTP for a period of one month before an application for cash advance can be considered.

Commission is payable one month in arrears from client being funded.
